The Petition of Tiffany Hunt Nielsen for a writ of mandate pursuant to Elections Code § 13313 came on for hearing on August 29, 2022 at 10:30 a.m. in Department 4 of this Court. IT IS HEREBY ORDERED THAT: The Candidate's Statement of Tiffany Hunt Nielsen be amended to read as set forth in Exhibit A hereto. The Humboldt County Elections Official, Kelly E. Sanders, is authorized and directed to replace the original candidate's statement of Tiffany Hunt Nielsen for the November 8, 2022 general election with the amended

2 Statement, so amended, as required by the Elections Code.
